**Fund Strategy:** The investment programs employed in our ITB Time Value Trading Program Composite are discretionary, and revolve around various options strategies, both long and short, based on the implied volatility of the S&P 500, and the perceived movement over the life of the selected options. The options we trade are on S&P 500 futures contracts, with the great majority bought or sold on the current front month. The objective is to generate income, combined with opportunistic long investments for hedging purposes and incremental returns.

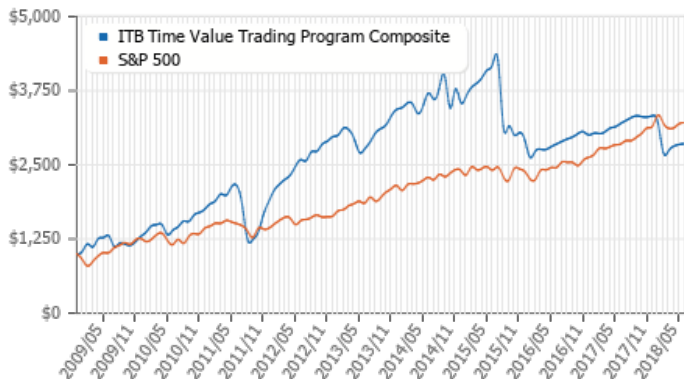
